



**Instructions for Autosave PLUS
(Sign up Procedure) On Line**

1. Log onto website www.autosave.ca/plus
2. Print out new Autosave Dealer Agreement.
3. Properly complete ALL required info on Dealer Agreement.
4. Fax completed agreement to 800 790-1248 immediately.
5. You MUST be a currently enrolled Autosave dealer in good standing to offer the "PLUS" enhancements to your retail customers.
6. New first time dealers need assigned a username & password.
7. All dealers will then log onto: www.autosave.ca

After clicking on the "Dealer Log In" block, (upper right hand corner)

Dealer will be required to input his:

- i. Dealer User Name
- ii. Dealer Password

Once into system, at this point dealer will have access to:

- a. **View my Invoice**- showing amounts currently due on sold contracts
- b. **Create new warranties**: Print ALL Autosave contracts on line
- c. **Manage warranties sold**: Reprints
- d. **Supplies**: Order Autosave of Canada marketing supplies

General Information

1. Section 4 & 5 of new dealer agreement must be initialed by person signing on the agreement
2. Electrical and/or air conditioning are optional coverage's.
3. Once a dealer elects to put seals & gasket coverage on any unit, he will automatically be locked into seals & gasket coverage as a mandatory surcharge.
4. Notify all dealers according to Dealer Agreement Section 4, that they MUST remit proper funds to Autosave on or before the 10th of each month for the preceding month's business.
5. The only contract available in paper form is the 5 / 160.
6. Monthly statements will be provided to Agent and Dealer for proper and timely submission of funds with on-line contracts.



ENHANCEMENT COVERAGES TO STANDARD PROGRAMS

AIR CONDITIONING

Compressor (primary only), condenser, evaporator and orifice tube. The following component(s) are also covered if required in connection with the repair of the vehicle, receiver dryer.

ELECTRICAL

Alternator, starter motor, starter solenoid, voltage regulator, fan blower motor and switch (primary only), windshield washer pump and rear defogger switch.

MAJOR SEALS & GASKETS

Coverage's include only the following gaskets and seals as listed: Intake manifold gaskets, Valve cover gasket(s), cylinder head gasket(s), front and rear engine and transmission seals. Note: sweating gaskets(s) or dripping gasket(s) or the seepage of gaskets are considered normal and acceptable operational conditions and are not covered. Minor leaks to the above seals or gaskets are considered to be normal operating conditions, and will not be considered as a claim, unless proven to cause the engine or transmission to operate below normal manufactures standards, not including normal wear and tear or diminished performance. Seals and gaskets that have failed due to operator negligence, excessive heat or overheating of any kind regardless of the cause are non-eligible repairs.

Five Year Aggregate(s)

The limit of liability per covered vehicle is \$3,000.00 per engine, \$2,000.00 per transmission, \$1,500.00 per transfer case, \$1,000.00 per limited air conditioning option, \$1,000.00 per limited electrical option and \$1000.00 per limited seals & gaskets option when applicable surcharge(s) has been paid and initialed in full these amounts are in the aggregate.

Three Year Aggregate(s)

The limit of liability per covered vehicle is \$2000.00 per engine,\$1,500.00 transmission,\$1,000.00 per transfer case,\$750.00 per limited air conditioning option, \$750.00 per limited electrical option and \$750.00 per limited seals & gaskets option when applicable surcharge(s) has been paid and initialed in full these amounts are in the aggregate.

One Year Aggregate(s)

The limit of liability per covered vehicle is \$1500.00 per engine, \$1,000.00 transmission, \$1,000.00 per transfer case, \$500.00 per limited air conditioning option, \$500.00 per limited electrical option and \$500.00 per limited seals & gaskets option when applicable surcharge(s) has been paid and initialed in full these amounts are in the aggregate.

1. No cancellation or transfer procedure on 1 & 3 year programs.
2. Towing & Rental benefits not offered on 1 & 3 Year programs.
3. Towing & Rental benefits not available in California.
4. Dealer must have Dealer # and password to print contracts.
5. Printed copy of contract with customers' signature to be submitted to administrator.
6. Vehicles in excess of 240,000 kilometers at time of delivery are EXCLUDED from all 3 programs.
